Interface used carbon offsets to support our Carbon Neutral Floors™ program (2018 – April 2024) and Carbon Neutral Enterprise certification (2021 – April 2024).

Through Carbon Neutral Floors, all the flooring products that we sold – carpet tile, LVT, vinyl sheet and rubber – were carbon neutral across their full lifecycle. To compensate for the full life cycle carbon emissions that we were unable to eliminate, we purchased carbon offsets.

In selecting offset projects, Interface sourced offsets only from projects that met third-party verified carbon offset standards such as the Gold Standard (GS), the California Climate Action Reserve (CAR), the American Carbon Standard (ACR), or the Verified Carbon Standard (VCS) with some projects having additional certifications such as the Climate, Community & Biodiversity Standard (CCB). This assured that the carbon credits we used were real (had happened), additional (beyond business-as-usual activities), measurable and permanent. The quantity and retirement of offsets were verified under our third-party verification for Carbon Neutral Floors and Carbon Neutral Enterprise on an annual basis.
